- The cortège can leave from a private address prior to the funeral service at a local church, followed by committal at the local crematorium, churchyard or cemetery.
- The coffin can be taken into church the night before the funeral service if required, instead of having a second limousine.
- Listing floral tributes.
- Taking names at the funeral service.
- Acknowledging charitable donations.
